## Community Safety Plan 2025-2029



**Tackling acquisitive crimes and ASB**  
By 2028 we will have achieved:

- 60% reduction in recorded incidents of anti-social behaviour (e.g. drug-related activity) and the council and police respond to hotspots as they develop
- The number of recorded business crime offences reduced by 5%
- 90% of Business Crime Reduction Partnership with a minimum of 20 local businesses signed up
- The Fire service will complete a minimum of 720 fire audits per year to identify fire risks and potentially reduce the number of house/flat fires

**Tackling violence**  
By 2028 we will have achieved:

- 15% reduction in recorded incidents of serious violence (including knife and gun crime)
- 10% increase in the proportion of women and girls who report feeling safe in their local area
- Increase the number of coordinated multi-agency operations targeting modern slavery, human trafficking, and exploitation networks, by 33%
- Create and implement a clear offer from the council and police to support children remaining in mainstream education by Q2 of 2028

**Tackling drug supply and substance misuse**  
By 2028 we will have achieved:

- 15% reduction in the number of recorded drug trafficking offences
- 100% of the top 50 problematic individuals identified for prevent, detect, and assess drug related criminal behaviour are managed through Integrated Offender Management (IOM) or targeted enforcement
- Individuals who have successfully completed drug treatment has increased

**Tackling hate crime and improving community cohesion**  
By 2028 we will have achieved:

- 8% increase in the proportion of residents from under-represented or over-policed communities reporting trust and confidence in local policing, measured annually
- 15% reduction in repeat hate crime victimisation
- Increase in the number of residents that feel people in their local area from different backgrounds get on well together

Launched on 19. December 2025

### The complete lack of reference to the ASB Policy or ASB provision is obvious.

**ASB policy** approval has now been set back to 18. February 2026. There are 70+ ASB officers patrolling in Tower Hamlets without an officially sanctioned ASB Police and ASB must be mentioned in the Community Safety Plan.

### Hate Crime

Whilst Council published proudly: "Tower Hamlets is recognized for its strong community cohesion, with 91% of residents expressing that they get on well together, despite being one of the most densely populated areas in the UK." The official Community Safety Plan mentions more community Cohesion is needed. The Hate Crime Plan also strongly expresses a preference for supporting left-wing political movements and declares all non-left political expressions as being the cause of all problems.

"The emergence of far-right activism in 2024 has put a strain on community tensions across the country, with some protests evolving into rioting behaviours: particularly in communities that are home to people of global majority backgrounds." The Council says on Page 38 of the Community Safety Plan 2025-29 from Council. It may be already out of date as it relies on the old hate crime handling. See our latest article on the issue. We support all national laws that support safety and crime prevention for all without political prejudice. **All legally operating political parties have the same rights under the law.**

We do not support the demand to reduce Stop and Search as mentioned in the Safety Plan on page 38, where a disproportionality is implied as given fact.

While there are concerns about the use of stop and search powers, the police have not been definitively found to accept disproportionality.

We think it's peculiar that local Tower Hamlets Police promote this Community Safety Plan as is.

The proposed reduction of police forces in England and Wales to 12 is part of a significant restructuring initiative led by Home Secretary Shabana Mahmood. This plan aims to merge the current 43 territorial forces into 12 large regional mega-forces to enhance efficiency and reduce costs. The reforms are expected to streamline oversight to local mayors and councils, which will also save taxpayers an estimated £100 million in the coming years.

### **New Estate Strategy set outs plan to put neighbourhood policing at the heart of London's communities**

The Met is calling on partners to help deliver 40 new policing hubs for neighbourhood teams across London, as part of major plans to ensure the Met Police is at the heart of the communities it serves to tackle crime and drive down violence.

Up to 200 police buildings to be sold and instead policing hubs, which are within 20-minute walking distance to be created.

## **Victims of Crime cry for help**

### **Ensure you report correctly:**

#### **All emergencies must call 999**

- 1. Report on the Met Police website, or at a station**
- 2. make a report and get a reference**
- 3. ask for a follow up**

- 1. Communicating with Police is safest from the Met Police website or in person at a police station.**
- 2. Do not report crime or ask for crime up-dates on Met Engage. Use Met Engage as source of information only.**

We get actual victims of crime who are in distress contacting us, stating that they cannot get help for their problem.

We assure you, we never engage in direct action with criminals, but we realise that any victim of crime, gets disoriented, feels powerless and loses proportional thinking.

People who lead busy lives and have families, jobs, friends; have little time to negotiate the forest of information that is available online.

Met Police have now created various layers of communication, which increases the choice to contact them but does not make it easily clear to victims of crime what is the most effective method.

## Compensation for victims of scams and fraud (spread the word)

If you have been coerced or manipulated into sending money to criminals, you are not on your own, and UK rules now offer stronger protection. Since 7 October 2024, the Payment Systems Regulator has introduced a mandatory reimbursement approach for most situations where money has been transferred to criminals through common bank transfer routes. In many eligible cases, you should get your money back quickly, typically within five business days of making your claim, although banks can take longer in specific circumstances.

There are limits. Banks can apply an excess of up to £100 per claim, and they should not apply this to vulnerable customers. The standard maximum reimbursement under the rules is £85,000 per claim.

If you have had more than £85,000 stolen and it is not fully repaid, you can escalate the complaint to the Financial Ombudsman service. If this happens to you, contact your bank straight away and ask to start a reimbursement claim.

## Direct Debit Scams – it is always worth checking!

The Scams Team is seeing a rise in Direct Debits being set up in people's names without clear consent. This can happen after details are gathered through manipulated calls, misleading websites, or unclear forms. These scams have been related to white goods service plans and drainage protection, but they could come in any form.

Please take a couple of minutes this week to check your bank statements, and your list of active Direct Debits, for anything you do not recognise. You can get the list on your online banking or by phoning your bank by dialling 159 on your phone and asking for the bank that you bank with. If you spot a payment or instruction, you did not authorise, call your bank straightaway, ask them to cancel it and raise a refund claim.
